LSEG All Share Acquisition of Refinitiv – European Commission Approval

London Stock Exchange Group plc (**LSEG**) confirms that the European Commission has conditionally approved, under the EU Merger Regulation, its proposed all share acquisition of Refinitiv (the **Transaction**).

The Transaction remains subject to a small number of merger control and financial regulatory authority approvals and is expected to complete shortly in Q1 2021.
