Our industry-leading proprietary standardisation model supports peer-to-peer and sector analysis, and our standardised fundamentals data provides a harmonised view of company financials. This can accelerate the screening process for companies across different markets and industries.

Detailed data that an entity files in the form of their financial statements is included. The granular, as reported taxonomy mirrors company-specific reporting across six industry templates with the flexibility to accommodate different income statement models and an operating cash flow section – all common measures used for data analysis.

Together, this provides users with a company's current financial health and when combined historically, the financial history of the company. As a result, research into company financials can be done with greater ease and confidence.

Our Company Fundamentals dataset provides coverage of up to 108,000 active and inactive, both public and private/ex-public companies traded in 150+ markets. This equates to 99% of the market capitalisation – covering both developed and emerging markets. Its rich data history with up to 40 years of annual data available encompasses US company data going back to the early 1980s, with the rest of the world going back to the 1990s. Now including 6,500+ fields of data points and historical analytics, segment data has been coded to TRBC codes, with 700+ operating metrics across 22 industries.
