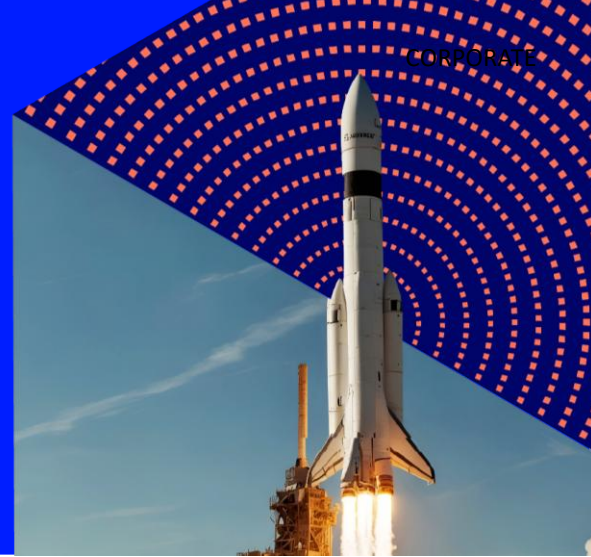

LSEG provides comprehensive coverage of corporate announcements from public, private companies and investment firms, concisely summarised into short News Briefs using GenAI.

Our global company news service includes corporate announcements and disclosures from companies to keep financial professionals informed about financially relevant company activities. Leveraging GenAI, we already offer concise bullet-form summaries of those releases as News Briefs to alert financial professionals to new corporate events across a wide – and increasing – spectrum of public companies and are now expanding the service to incorporate additional coverage of 60K private companies and 30K investment firms.

News Briefs cover market-sensitive disclosures from companies listed in supported markets, regardless of the channel used for dissemination, including press release wires, filings and regulatory wires and corporate/investor relations websites. In addition, updates on private entities are available, which are especially valuable as unlisted companies often don't report through traditional channels, making updates harder to source.

The workflow

With the accelerated shift of companies posting announcements to their websites instead of, or ahead of, posting via traditional press release wires, our automated solution captures announcements that might otherwise be missed. While Reuters journalists focus on hard-hitting and in-depth journalism about companies, the addition of News Briefs to our global company news service provides financial professionals with rapid and comprehensive company coverage.

All News Briefs include either a link to the original document for non-licensed content or a source identifier and document name for licensed content, ensuring transparency and allowing users a pathway to view the original content.

Coverage of public company News Briefs is currently expanding by country each month.

United States: ~6,000 listed and ~5,000 OTC companies

Canada: ~3,200 companies

France, Belgium, Netherlands, Luxembourg: ~1,000 companies (provided in English, French and Dutch)

Germany, Switzerland, Austria: ~1,200 companies (provided in English and German)

Norway, Sweden, Denmark, Finland, Iceland: ~1,600 companies (provided in English, Norwegian, Danish, Swedish, Finnish and Icelandic)

Singapore: ~600 companies

Hong Kong: ~2,500 companies

South Africa: ~240 companies

Private markets

Coverage is currently expanding at a rate of 2,100 companies each month and by Q1 2027 will include a combination of 30K investment firms and 60K private companies.

These private company announcements, including Private Equity and Venture Capital firms, provide timely insights into capital flows, market trends, and portfolio company performance and help transform raw investment data into actionable intelligence, enabling faster, better-informed decisions.

Coverage includes the following topics:

- Earnings and financial disclosures including earnings and financial results, corporate actions (bankruptcy, company dissolution and liquidation, corporate debt, dividends, equity financing and capital changes)
- Corporate deals (M&A, asset deals, concession agreements, alliances and joint ventures, minority interest transactions)
- Governance and appointments
- Regulatory filings and reporting; regulatory issues (approvals, environmental issues, fines and violations); corporate litigation
- Sales and production guidance; sales, contracts and orders, product issues and recalls, production and operations
- Research & Development and IP
