LSEG launches a new AI-assisted format from Reuters substantially expanding company news coverage



LSEG has launched Reuters Super Summaries, delivering crucial, market-moving company events concisely summarised at speed to gain a competitive edge and make critical investment decisions.

Reuters Super Summaries are a new AI-assisted format that expand the scope of LSEG's company news coverage down the market capitalisation stack. A hybrid of human and machine intelligence, Super Summaries uniquely combine trusted journalism and insights from Reuters with analysts' estimates and market data from LSEG.

Reuters currently delivers in-depth reporting on numerous companies across the world's major stock indices, such as the S&P 500. Super Summaries target additional firms with initial coverage centred on company earnings for 3,500 US and Canadian businesses by year-end. The scope of global coverage is expected to expand over time to encompass 10,000 companies.

## Content format

The story format consists of six sections – story headline, overview, outlook, result drivers, key details and analyst coverage. New features and sections will be added over time.

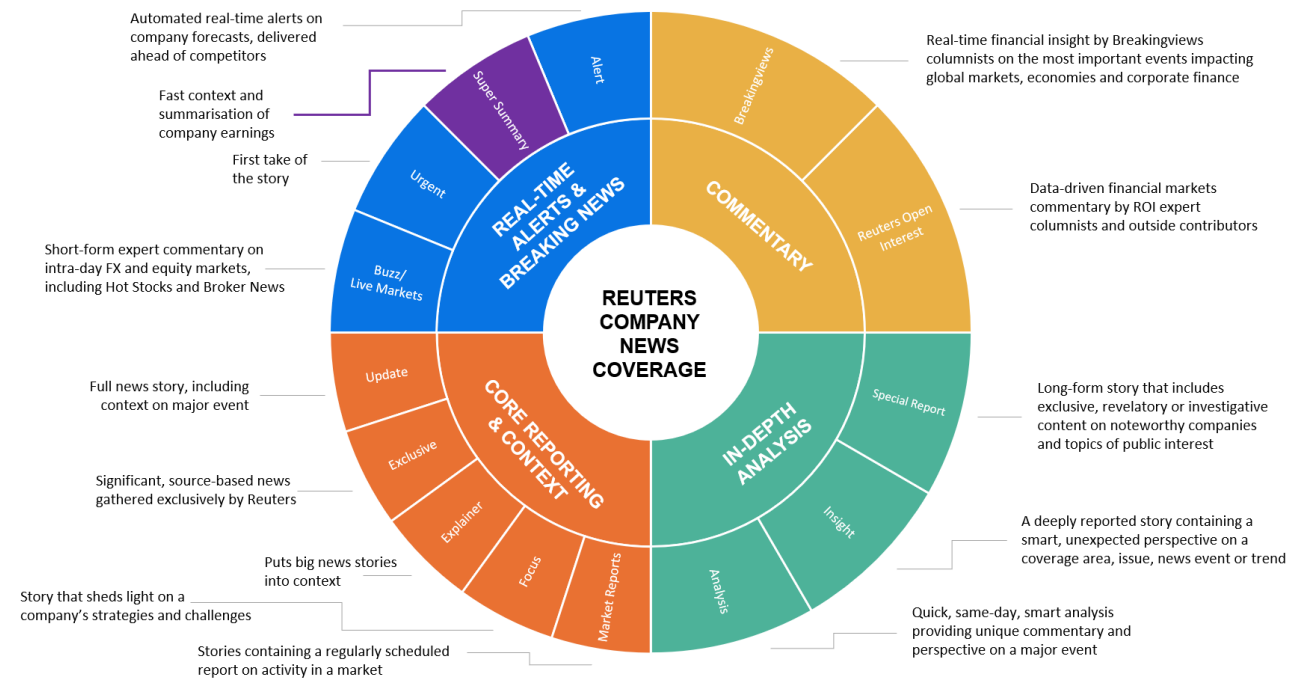
Editorial oversight and transparency
