CRB®ANNOUNCEMENT FOLLOWING CONSULTATION

EXCEPTIONAL FORWARD ROLL OF WTI CRUDE OIL FUTURES

Refinitiv Benchmarks Services (UK) Limited, as the benchmarks administrator for the Refinitiv/CoreCommodity CRB® Index (along with sub-indices) previously requested wider market feedback on the Index methodology to address exceptional market conditions, including the negative settlement price of the WTI Crude Oil May 2020 futures contract.

As a result of the market input, Refinitiv Benchmarks Services (UK) Limited, after consultation with the Refinitiv/CoreCommodity CRB Oversight Committee, has decided to apply a one-off modification to the roll schedule for certain WTI futures contracts. Refinitiv Benchmarks Services (UK) Limited is communicating with applicable regulators with respect to these changes and is applying its operational policies to protect benchmark reliability.

In addition, and in consideration of market input provided, Refinitiv Benchmarks Services (UK) Limited is continuing to review its policies in relation to the possibility of zero or negative settlement prices of index constituent contracts or of indices on any non-roll date, roll date, or rebalance date.
