Section 1

Introduction

1. Introduction

1.1 FTSE Chinese Government and Policy Bank Bond 1-10 Years Capped Index

- 1.1.1 The FTSE Chinese Government and Policy Bank Bond 1-10 Years Capped Index measures the performance of the Yuan-denominated fixed-rate government and policy bank bonds in the FTSE Chinese Government and Policy Bank Bond Index that are traded on the China Interbank Bond Market (CIBM) and with an average life of less than 10 years. The eligible Chinese policy bank bonds are those issued by the China Development Bank, the Agricultural Development Bank of China, and the Export-Import Bank of China. These policy banks are state-owned and their objectives typically include providing social benefit, stimulating the economy, and supporting growing local industries. The market capitalisation-based weight of the each policy bank issuer is capped at 9%.
- 1.2 The FTSE Chinese Government and Policy Bank Bond 1-10 Years Capped Index does take account of ESG factors in its design.

Management responsibilities

2. Management responsibilities

2.1 FTSE International Limited (FTSE)

2.2 FTSE is the benchmark administrator of the index series¹.

2.2.1 FTSE is responsible for the daily calculation, production and operation of the index series and will:

- maintain records of all the constituents;
- be responsible for the addition and deletion of bonds and changes of nominal amounts, in accordance with the Ground Rules.
- disseminate the indices.

2.3 Amendments to these Ground Rules

2.3.1 These Ground Rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they best reflect the aim of the index series. Any proposals for significant amendments to these Ground Rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell Index Governance Board before approval is granted.

2.3.2 As provided for in the Statement of Principles for FTSE Russell Fixed Income Indices, where FTSE Russell determines that the Ground Rules are silent or do not specifically and unambiguously apply to the subject matter of any decision, any decision shall be based as far as practical on the Statement of Principles. After making any such determination, FTSE Russell shall advise the market of its decision at the earliest opportunity. Any such treatment will not be considered as an exception or change to the Ground Rules, or to set a precedent for future action, but FTSE Russell will consider whether the Ground Rules should subsequently be updated to provide greater clarity.

3.1 Statement of Principles for FTSE Fixed Income Indices (the Statement of Principles)

Where the Ground Rules do not fully cover a specific event or development, FTSE Russell will determine the appropriate treatment by reference to the Statement of Principles for FTSE Fixed Income Indices which summarises the ethos underlying FTSE Russell's approach to index construction. The Statement of Principles is reviewed annually and any changes proposed by FTSE Russell are presented to the FTSE Russell Policy Advisory Board for discussion before approval by the FTSE Russell Index Governance Board. 4. Composition and design criteria

4.1 The Index is based on the FTSE Chinese Government and Policy Bank Bond Index (CNGPBI). For more information, please see the FTSE Fixed Income Index Guide.

Minimum maturity	At least one year and less than 10 years
Minimum issue size	Government: CNY 100billion on CGBs issued before 01 January 2020, CNY 35billion on CGBs issued on or after 01 January 2020; Policy Bank: CNY 15 billion

4.2 Holiday calendar

4.2.1 The index is calculated Monday through Friday except Christmas Day (observed) and New Year's Day (observed). Each local market will observe its own holiday calendar; if a local market is on holiday, the closing prices used for that day will be the closing prices from the previous day.

4.3 Index quality

4.3.1 An index quality is assigned to each index bond as of profile fixing. The quality is first mapped to the Standard & Poor's Financial Services LLC ("S&P") rating. If a bond is not rated by S&P but it is rated by Moody's Investors Service, Inc ("Moody's"), the S&P equivalent of the Moody's rating is assigned to the index quality. If a bond is rated by neither S&P nor Moody's, the bond is not assigned an index quality. If a bond is rated as investment-grade by one rating agency and high-yield by the other, the S&P equivalent of the investment-grade rating is assigned to the index quality. These ratings remain unchanged for the entire performance month.

4.4 Return computation

4.4.1 Total returns are computed on the assumption that each security is purchased at the beginning of the period and sold at the end of the period. An issue's total rate of return is the percentage change in its total value over the measurement period. The components of total return for each security are price change, principal payments, coupon payments and accrued interest. The total returns are market capitalisation-weighted using the security's beginning-of-period market value (see Figure 2).

Figure 2. Total rate of return calculation methodology

Beginning-of-period value	-	(Beginning price + Beginning accrued) x Beginning par amount outstanding
End-of-period value	-	[(Ending price + Ending accrued) x (Beginning par amount outstanding – Principal payments)] + Coupon payments + Principal payments
Total rate of return (%)	-	[(End-of-period value/Beginning-of-period value) – 1] x 100

A note on precision: Returns are computed to at least six decimal places but reported to a maximum of four. In addition, owing to rounding errors inherent in computer floating-point arithmetic, the last digit in any reported value may sometimes be off by one from its true value.

Year	Monthly highlights
2021	July: The minimum issue size for Chinese government bonds issued before 01 January 2020 is changed from CNY 35 billion to CNY 100 billion.
2020	September: The minimum issue size for Chinese government bonds is changed from CNY 20 billion to CNY 35 billion. May: The FTSE Chinese Government and Policy Bank Bond 1-10 Years Capped Index is introduced.
