Section 1

Introduction

1. Introduction

1.1 FTSE Goldman Sachs China Government Bond Index

1.2 The FTSE Goldman Sachs China Government Bond Index measures the performance of Chinese Yuan-denominated, fixed-rate government bonds issued in mainland China. Any bonds with maturity greater than 30 years from issuance are excluded from the index.

1.2.1 The FTSE Goldman Sachs China Government Bond Index Series does not take account of ESG factors in its index design.

1.3 FTSE Russell

FTSE Russell is a trading name of FTSE International Limited, Frank Russell Company, FTSE Global Debt Capital Markets Limited (and its subsidiaries FTSE Global Debt Capital Markets Inc. and FTSE Fixed Income Europe Limited), FTSE Fixed Income LLC, FTSE (Beijing) Consulting Limited, Refinitiv Benchmark Services (UK) Limited, Refinitiv Limited and Beyond Ratings.

Section 2

Management responsibilities

2. Management responsibilities

2.1 FTSE Fixed Income LLC (FTSE)

2.1.1 FTSE is the benchmark administrator of the index series¹.

2.1.2 FTSE is responsible for the daily calculation, production and operation of the index series, and will:

- maintain records of all the constituents;
- be responsible for the addition and deletion of bonds and changes of nominal amounts, in accordance with the Ground Rules; and
- disseminate the indices.

2.2 Amendments to these Ground Rules

2.2.1 These Ground Rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they best reflect the aim of the index series. Any proposals for significant amendments to these Ground Rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell Index Governance Board before approval is granted.

2.2.2 As provided for in the Statement of Principles for FTSE Russell Fixed Income Indices, where FTSE Russell determines that the Ground Rules are silent or do not specifically and unambiguously apply to the subject matter of any decision, any decision shall be based as far as practical on the Statement of Principles. After making any such determination, FTSE Russell shall advise the market of its decision at the earliest opportunity. Any such treatment will not be considered as an exception or change to the Ground Rules, or to set a precedent for future action, but FTSE Russell will consider whether the Ground Rules should subsequently be updated to provide greater clarity.

3. FTSE Russell index policies

These Ground Rules should be read in conjunction with the following policy documents, which can be accessed using the links below or by contacting fi.index@lseg.com. These policies are reviewed annually and any changes are approved by the FTSE Russell Index Governance Board.

3.1 Statement of Principles for FTSE Fixed Income Indices (the Statement of Principles)

Indices need to keep abreast of changing markets and the Ground Rules cannot anticipate every eventuality. Where the Ground Rules do not fully cover a specific event or development, FTSE Russell will determine the appropriate treatment by reference to the Statement of Principles for FTSE Fixed Income Indices, which summarises the ethos underlying FTSE Russell's approach to index construction. The Statement of Principles is reviewed annually and any changes proposed by FTSE Russell are presented to the FTSE Russell Policy Advisory Board for discussion before approval by the FTSE Russell Index Governance Board.

Currency	CNY
Minimum maturity	At least one year
Minimum issue size	CNY 35 billion for bonds issued after 1 January 2020 CNY 100 billion for bonds issued prior to 1 January 2020
Composition	Securities included: fixed-rate government bonds Securities excluded: zero-coupon bonds, saving bonds, special government bonds, bonds with maturity greater than 30 years from issuance and bonds issued prior to 1 January 2005
Weighting	Market capitalisation
Rebalancing	Once a month at the end of the month
Reinvestment of cash flows	Intra-month cash flows from interest and principal payments are not reinvested as part of monthly index total return calculations ⁵ .
Pricing	Refinitiv mid-side at 18:00 (Tokyo)
Calculation frequency	Daily
Settlement date	Monthly: settlement is on the last calendar day of the month. Daily: same-day settlement, except if the last business day of the month is not the last calendar day of the month; then, settlement is on the last calendar day of the month.
Fixing date	Each month, the upcoming month's index constituents are fixed on the profile fixing date. The profile fixing dates for each year are available on the website at www.lseg.com/en/ftse-russell/
Base date	28 February 2009

4.1 Holiday calendar

4.1.1 The index is calculated Monday through Friday except Christmas Day (observed) and New Year's Day (observed). Each local market will observe its own holiday calendar: if a local market is on holiday, the closing prices used for that day will be the closing prices from the previous day.

4.2 Index quality

4.2.1 An index quality is assigned to each index bond as of profile fixing. The quality is first mapped to the Standard & Poor's Financial Services LLC (S&P) rating. If a bond is not rated by S&P but it is rated by Moody's Investors Service, Inc (Moody's), the S&P equivalent of the Moody's rating is assigned to the index quality. If a bond is rated by neither S&P nor Moody's, the bond is not assigned an index quality. If a bond is rated as investment grade by one rating agency and high yield by the other, the S&P equivalent of the investment-grade rating is assigned to the index quality. These ratings remain unchanged for the entire performance month.

4.3 Exchange rates

4.3.1 The closing Refinitiv Spot Rates and The Refinitiv Forward Rates, provided by Refinitiv, are used. Refinitiv takes several snapshots at regular intervals centred on the fixing time of 16:00 London time and selects the median rate for each currency. All rates are mid-market quotations and appear on Refinitiv (see WMRSPT01).

4.4 Return computation

4.4.1 Total returns are computed on the assumption that each security is purchased at the beginning of the period and sold at the end of the period. An issue's total rate of return is the percentage change in its total value over the measurement period (see figure two). The components of total return are price change, principal payments, coupon payments and accrued interest. The total returns use each individual security's beginning-of-period market value.

Figure two: total rate of return calculation methodology

Beginning-of-period value	-	(Beginning price + Beginning accrued) x Beginning par amount outstanding
End-of-period value	-	[(Ending price + Ending accrued) x (Beginning par amount outstanding – Principal payments)] + Coupon payments + Principal payments
Total rate of return (%)	-	[(End-of-period value/Beginning-of-period value) - 1] x 100

A note on precision: returns are computed to at least six decimal places but reported to a maximum of four. In addition, owing to rounding inaccuracies inherent in computer floating-point arithmetic, the last digit in any reported value may sometimes be off by one from its true value.

Figure three: total rate of return calculation methodology for base currency returns, unhedged

Total rate of return (%)

$$\left\{ \left[1 + \left(\frac{\text{Local Currency Return}}{100} \right) \right] \times \left(\frac{\text{End-of-Month Spot Rate}}{\text{Beginning-of-Month Spot Rate}} - 1 \right) \right\} \times 100$$

This equation holds true only if the spot rates are quoted as base currency per unit of foreign currency.

Figure five: FTSE Goldman Sachs China Government Bond Index event summary

Year	Highlights
2022	November: intra-month cash flows from interest and principal payments are not reinvested as part of monthly index total return calculations.
2021	July: minimum issues size changed from CNY 35 billion to CNY 100 billion for bonds issued prior to 1 January 2020. June: change in timing of pricing used in index.
2020	September: the minimum issue size is changed from CNY 20 billion to CNY 35 billion. April: the minimum issue size changed to reflect net reopenings and buybacks conducted as part of government market making operations.
2019	July: pricing source is changed from Refinitiv bid pricing to Refinitiv mid pricing.
2018	August: pricing source changed from Citi trader to Refinitiv. November: the reinvestment rate for the Chinese onshore currency bonds changed from one-month deposit rate to the savings deposit rate published by the People’s Bank of China.
