Introduction

1. Introduction

1.1 FTSE Goldman Sachs US Investment-Grade Bond 10+ Years Index

- 1.2 The FTSE Goldman Sachs US Investment-Grade Corporate Bond 10+ Years Index tracks the performance of US Dollar-denominated investment-grade corporate debt. The index provides a broad representation of the US investment grade corporate bond market while reducing the weight of issuers with the lowest operating margin and highest leverage.
- 1.2.1 The index is created from the FTSE US Broad Investment-Grade Corporate Bond Index with average life greater than or equal to 10 years (Base Index), which includes US and non-US corporate securities issued in registered form and bonds issued under rule 144A with registration rights. The universe screens issuers based on minimum bonds outstanding to represent the more liquid portion of the market and by applying fundamental indicators. The bonds are then ranked within their respective industries based on fundamental indicators. Bonds from the lowest ranked 10% of issuers are reweighted where their initial market capitalization are reduced by half. The market capitalization of the remaining 90% of issuers with high operating margin and low leverage, along with bonds of issuers that satisfy the liquidity criteria but have neither fundamental indicator available, are left unchanged. The bonds are then dividend into two maturity buckets based on the weighted average life of the Base Index, after which the weights of each maturity bucket are adjusted to match the weighted average effective duration of the bonds in the Base Index. Within each maturity bucket, constituents are assigned weights in proportion to their market capitalization. Issuer weights are then capped at 5% for issuers with fundamental indicators and 3% for issuers where fundamental indicators are not observable.

Management responsibilities

Management responsibilities

2.1 FTSE International Limited (FTSE)

- 2.1.1 FTSE is the benchmark administrator of the index¹.
- 2.1.2 FTSE is responsible for the daily calculation, production and operation of the index series, and will:
 - maintain records of all the constituents;
 - be responsible for the addition and deletion of bonds and changes of nominal amounts, in accordance with the Ground Rules; and
 - disseminate the indices.

2.2 Amendments to these Ground Rules

- 2.2.1 These Ground Rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they best reflect the aim of the index series. Any proposals for significant amendments to these Ground Rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell index governance board before approval is granted.
- As provided for in the Statement of Principles for FTSE Russell Fixed Income Indices, where FTSE Russell determines that the Ground Rules are silent or do not specifically and unambiguously apply to the subject matter of any decision, any decision shall be based as far as practical on the Statement of Principles. After making any such determination, FTSE Russell shall advise the market of its decision at the earliest opportunity. Any such treatment will not be considered as an exception or change to the Ground Rules, or to set a precedent for future action, but FTSE Russell will consider whether the Ground Rules should subsequently be updated to provide greater clarity.

3. FTSE Russell index policies

3.1 Statement of Principles for FTSE Fixed Income Indices (the Statement of Principles)

Indices need to keep abreast of changing markets and the Ground Rules cannot anticipate every eventuality. Where the Ground Rules do not fully cover a specific event or development, FTSE Russell will determine

the appropriate treatment by reference to the Statement of Principles for FTSE Fixed Income Indices, which summarises the ethos underlying FTSE Russell's approach to index construction. The Statement of Principles is reviewed annually and any changes proposed by FTSE Russell are presented to the FTSE Russell Policy advisory board for discussion before approval by the FTSE Russell Index governance board.

3.6 FTSE Russell Governance Framework

3.6.1 To oversee its indices, FTSE Russell employs a governance framework that encompasses product, service and technology governance. The framework incorporates the London Stock Exchange Group's three lines of defence risk management framework and is designed to meet the requirements of the IOSCO Principles for Financial Benchmarks², the European benchmark regulation³ and the UK benchmark regulation⁴. 4. Composition and design criteria

4.1 Figure one details the design criteria and calculation assumptions for the FTSE Goldman Sachs US Investment-Grade Corporate Bond 10+ Years Index.

Fundamental ranking and reweighting – the bond universe reweight is determined by two fundamental indicators reported by the issuers: improvement over the past year in (1) operating margin and (2) leverage, both determined quarterly at the end of February, May, August and November. Operating margin is measured by earnings before interest and taxes margin (EBIT margin), while leverage is measured by debt to enterprise value (debt to EV). The issuers are ranked within their respective industry (finance, industrial, and utility) positively by operating margin and negatively by leverage, accounting for market capitalization to determine the percentile ranking. The percentile rankings of individual indicators are combined to calculate each issuer's composite rank. When only a single indicator is available, that single indicator will be used to calculate the issuer's composite rank. The issuers within the lowest 10% composite rank are reweighted such that their market capitalizations are reduced by half⁵, while issuers in the remaining 90%, along with bonds of issuers that satisfy the liquidity criteria but have neither fundamental indicator available, are left unchanged. Duration adjustment – bonds are divided into two maturity buckets based on weighted average life of the Base Index, after which weights of each maturity bucket are adjusted to match the weighted average effective duration of the Base Index. Within each maturity bucket, constituents are assigned weights in proportion to their market capitalization. Issuer capping – issuer weights are capped at 5% for issuers with fundamental indicators and 3% for issuers where fundamental indicators are not observable. An iterative process of steps 2 and 3 ar

	5. For the non-quarter-end months, bonds that no longer meet the liquidity, rating or maturity requirements are removed from the index. Newly issued bonds from the qualified issuers of the most recent quarterly rebalancing are included. The monthly profiles will reflect the latest par amount and market value of all included bonds. Reweight utilizes pricing and amounts outstanding of the base index in order to reconstruct index holdings and weights.

4.2 Holiday calendar

4.2.1 The index is calculated Monday through Friday except Christmas Day (observed) and New Year's Day (observed). Each local market will observe its own holiday calendar: if a local market is on holiday, the closing prices used for that day will be the closing prices from the previous day.

4.3 Index quality

4.3.1 An index quality is assigned to each index bond as of profile fixing. The quality is first mapped to the Standard & Poor's Financial Services LLC (S&P) rating. If a bond is not rated by S&P but it is rated by Moody's Investors Service, Inc (Moody's), the S&P equivalent of the Moody's rating is assigned to the index quality. If a bond is rated by neither S&P nor Moody's, the bond is not assigned an index quality. If a bond is rated as investment grade by one rating agency and high yield by the other, the S&P equivalent of the investment-grade rating is assigned to the index quality. These ratings remain unchanged for the entire performance month.

4.4 Defaults

4.4.1 When an issuer defaults, is assigned a D rating by S&P regardless of whether that issuer has filed for bankruptcy protection or enters into chapter 7 or chapter 11 bankruptcy protection in the US (or equivalent in its local market), its bonds remain in the index until the end of the month. The bonds will be included in the calculation of the current month's average profile statistics of the index. The returns are calculated without coupon payment or accrued interest, where applicable.

4.5 Return computation

4.5.1 Total returns are computed on the assumption that each security is purchased at the beginning of the period and sold at the end of the period. An issue's total rate of return is the percentage change in its total value over the measurement period (see figure four). The components of total return are price change, principal payments, coupon payments and accrued interest. The total returns use each individual security's beginning-of-period market value.

Fixing dates provide a clear reference point for index users to know in advance of any changes to the composition of the index for the upcoming month. On each fixing date, publically available securities information is used to determine index eligibility and indicative values for the following month's index profile.

⁸ Back-tested data from the base date up to and including May 29, 2020 was produced using pricing from Refinitiv 16:00 bid. From June 1, 2020 onwards the price source is Refinitiv 15:00 mid.
