#### 1. Introduction

#### 1.2 FTSE Russell

## Management responsibilities

#### Management responsibilities

#### 2.1 FTSE International Limited (FTSE)

- 2.1.1 FTSE is the benchmark administrator of the index<sup>1</sup>.
- 2.1.2 FTSE is responsible for the daily calculation, production and operation of the index series and will:
  - maintain records of the index weightings of all constituents;
  - make changes to the constituents and their weightings in accordance with the Ground Rules;
  - carry out the periodic index reviews of the index series and apply the changes resulting from the reviews as required by the Ground Rules;
  - publish changes to the constituent weightings resulting from their ongoing maintenance and the periodic reviews;
  - disseminate the indices.

#### 2.2 Amendments to these Ground Rules

2.2.1 These Ground Rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they continue to best reflect the aims of the index. Any proposals for significant amendments to these Ground Rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell Index Governance Board before approval is granted.

- 3.5.1 To oversee its indices, FTSE Russell employs a governance framework that encompasses product, service and technology governance. The framework incorporates the London Stock Exchange Group's three lines of defence risk management framework and is designed to meet the requirements of the IOSCO Principles for Financial Benchmarks<sup>2</sup>, the European benchmark regulation<sup>3</sup> and the UK benchmark regulation<sup>4</sup>. # Index methodology

#### Russell 2000 Dividend Index

#### 4.1 Review methodology

The index will represent the cumulative value of ordinary cash dividends announced and paid by the individual constituents of the underlying Russell 2000 Index, calculated in terms of index points. No adjustment for withholding taxes will be made.

FTSE Russell will rebase the index to 0 at the start of the first trading day following the third Friday in December each year.

#### 4.2 Ex-Dividend adjustment

The ex-dividend (xd) adjustment represents the value of dividends declared by constituent companies on the xd date expressed in index points. The xd adjustment year to date is the calculation on a cumulative basis for the period between and including the first trading day following the 3rd Friday in December to midday on the 3rd Friday in December of the following year. Xd adjustments are based on declared dividends. The xd adjustment is calculated as follows:

### Market value of dividends Latest index divisor

If a company declares a dividend in a currency other than US Dollar, the published USD equivalent will be used, if available prior to the xd-date. If there is no USD equivalent, the dividend will be converted to USD using the WM/Refinitiv 4PM rate the day before the stock goes xd.

#### 4.3 Corporate actions adjustment

The index will follow the standard FTSE Russell corporate action adjustments as detailed in the following document:

#### Corporate\_Actions\_and\_Events\_Guide

For example, if a company distributing an ordinary dividend subsequently announces a retraction (i.e. dividend is no longer being paid), FTSE Russell will apply a corrective negative adjustment with T+1 notice.

#### 4.4 Index calculation example

If Company A and B each declared a dividend payment with an xd date of day T, the following calculation would occur to derive the xd adjustment on day T:

Company	Dividend (\$)	Shares (m)	Free float factor	Market value (\$m)	XD adjustment (market value/divisor)
Α	1.25	61,443	0.9	69,123.38	1.97
В	0.63	22,579	1.0	14,224.77	0.81
Total xd adj	2.127				

Index divisor = 39,183

The method for calculating the xd adjustment uses the divisor as at the close of business on the preceding day after implementing any capitalisation changes. Where a company has more than one line of shares included in the indices, the xd adjustment is calculated separately for each line.
