

Executive Order 13959 - Proposed Treatment of Newly Sanctioned Names

Further to the 'Executive Order by the President of the United States of America – FTSE Russell invites comments on EO 13959 FAQ 902' notification published on 09 June 2021, FTSE Russell would like to thank all the index users and stakeholders who provided feedback on the updated Executive Order (EO) 13959 – Non-SDN Chinese Military-Industrial Complex Companies (NS-CMIC List) and Frequently Asked Questions 902 (FAQ 902).

After consideration of the responses, FTSE Russell will proceed with deleting the index constituents from FTSE Russell indices that under FAQ 902 may continue to hold NS-CMIC listed names on the basis that index users commented that they could not guarantee the absence of U.S. beneficial owners investing in funds tracking those indices in violation of EO 13959.

Following an evaluation of the NS-CMIC List the securities listed in the table below were identified as index constituents of FTSE Russell indices that fall within the scope of the updated EO 13959 and will consequently be deleted from the FTSE GEIS, the FTSE Global China A Inclusion indices and associated indices effective from the open on Wednesday 28 July 2021.
