- FTSE International Limited ("FIL") is authorised in the UK by the FCA under the UK Benchmark Regulation ("UK BMR");
- RBSL is authorised in the UK by the FCA under the UK BMR and designated as a benchmark administrator for CDOR under the Canadian Securities Administrators Benchmark Rule ("CSA Benchmark Rule") and Ontario Securities Commission Rule 25-101 ("OSC Rule"). For the list of benchmarks currently administered by RBSL please visit FTSE Russell benchmarks (the "RBSL Benchmarks").

In addition, FTSE Russell also calculates and publishes certain benchmarks and indices outside of these two authorised benchmark administrators. For these indices we are generally aligned with the International Organization of Securities Commissions ("IOSCO") Principles for Financial Benchmarks (the "IOSCO Principles").

IOSCO is a global body comprised of representatives from the world's financial regulators. In 2013 IOSCO produced a set of principles on governance, the quality of benchmark determinations, the quality of the methodologies used, and the accountability of the benchmark administrator.

In line with by the IOSCO Principles, FTSE Russell affirms its aim to be generally aligned with these Principles. FTSE Russell works to improve the calculation, management, and governance of the benchmarks and indices it calculates, publishes, or administers to ensure they reflect the highest standards and meet all applicable regulation and industry guidance.

For the RBSL benchmarks, we have made a commitment to ensure that methodologies are codified and available to stakeholders, that governance principles and control frameworks protect the integrity of the benchmark-setting process and that, where applicable, submitters are subject to a code of conduct. We believe it is the responsibility of everybody providing such data to ensure its integrity and we actively work to maintain confidence in these fundamental data on which the global financial system depends.

RBSL has published a <u>Statement relating to the IOSCO Principles for the WMR Financial Benchmarks</u>. In addition, FIL has published an <u>IOSCO Statement of Compliance</u>.

For the remaining indices calculated and published by FTSE Russell, we fully support IOSCO's approach, which applies a common set of principles across all jurisdictions, and we have been working to ensure full observance of these principles across these indices..ⁱⁱ

FTSE Russell is subject to both internal and external audits on a regular basis, including for certain benchmarks and indices specific IOSCO reviews and where required UK BMR regulatory audits.
