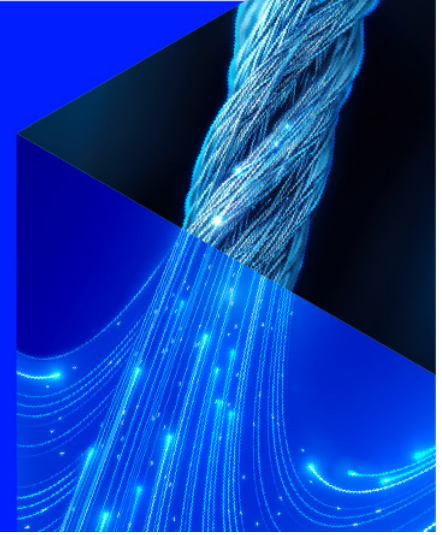

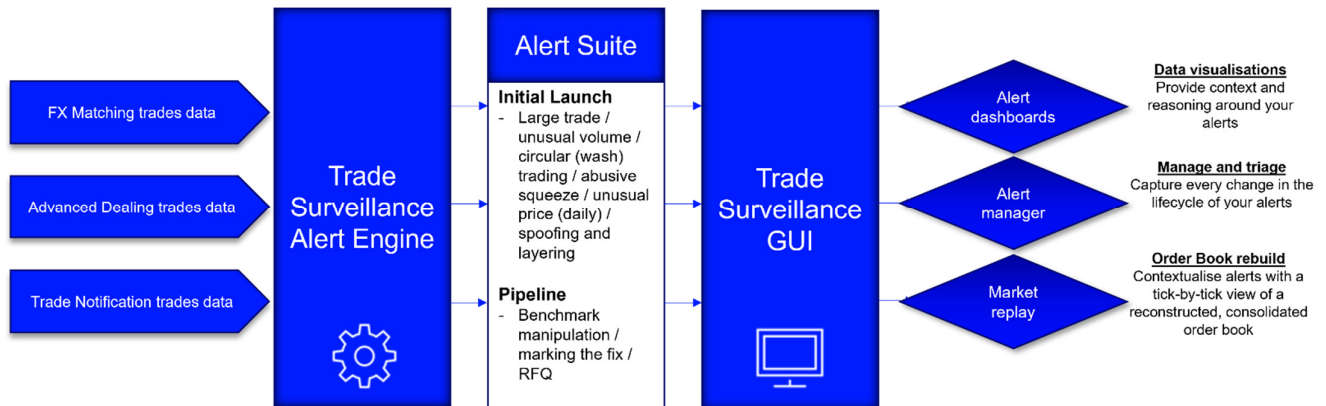

Trade Surveillance provides you with the capability to view your private trades against our public Spot Matching data feed, plus a range of alerts to help you assess and manage regulatory risk.

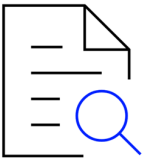

### Capitalise on your private trading data

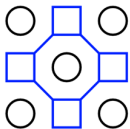
### Behavioural anomaly detection alerts
