### 3. Applicant declaration

We hereby confirm that, in accordance with London Stock Exchange Rules, we have undertaken due diligence regarding the suitability of the customer to have Sponsored Access to LSEG's markets. We have satisfied ourselves that the customer:

- Has sufficient staff with adequate knowledge, experience, training and competence for the activities it will undertake on London Stock Exchange's order books
- Has appropriate knowledge of LSEG Rules, with particular reference to the order book trading rules (2000 – 2025) and rules 1400 (misleading acts, conduct and prohibited practices) and 1410 (share price manipulation)
- Understands that Regulation (EU) No 596/2014 applies to all activity conducted on London Stock Exchange and has taken appropriate steps to ensure that its behaviour does not constitute market abuse
- Has adequate internal procedures and controls for these activities, notwithstanding the exchange level controls provided for all sponsored order flow
- Has appropriate financial resources
- Is fit and proper to have a direct technical connection to LSEG markets.

To the best of our knowledge – having undertaken due diligence on the Sponsored User – we are not aware that the provision of Sponsored Access to the Sponsored User, as described in the Guide to Sponsored Access, violates any laws or regulations in the relevant jurisdiction.

We confirm that, where we are providing sponsored access to a US Sponsored User as described in the Guide to Sponsored Access, it is done in accordance with United States Law, including US Securities and Exchange Commission Rule 15a-6 under the US Securities Exchange Act, as amended.

Furthermore, we confirm that we will have arrangements in place to satisfy ourselves on an ongoing basis that the customer continues to meet these requirements and, when requested, we will provide information to London Stock Exchange with respect to this. As required under the rules, we will notify LSEG immediately if we become aware that the customer no longer meets the requirements and will cooperate with London Stock Exchange to halt the customer's Sponsored Access to LSEG markets.

We accept that we are responsible for all obligations and liabilities arising from the trading activity undertaken on London Stock Exchange by the customer via Sponsored Access. We confirm that we have read and accept all the terms and conditions set out in the technical specification and that the information provided above is accurate and complete.
