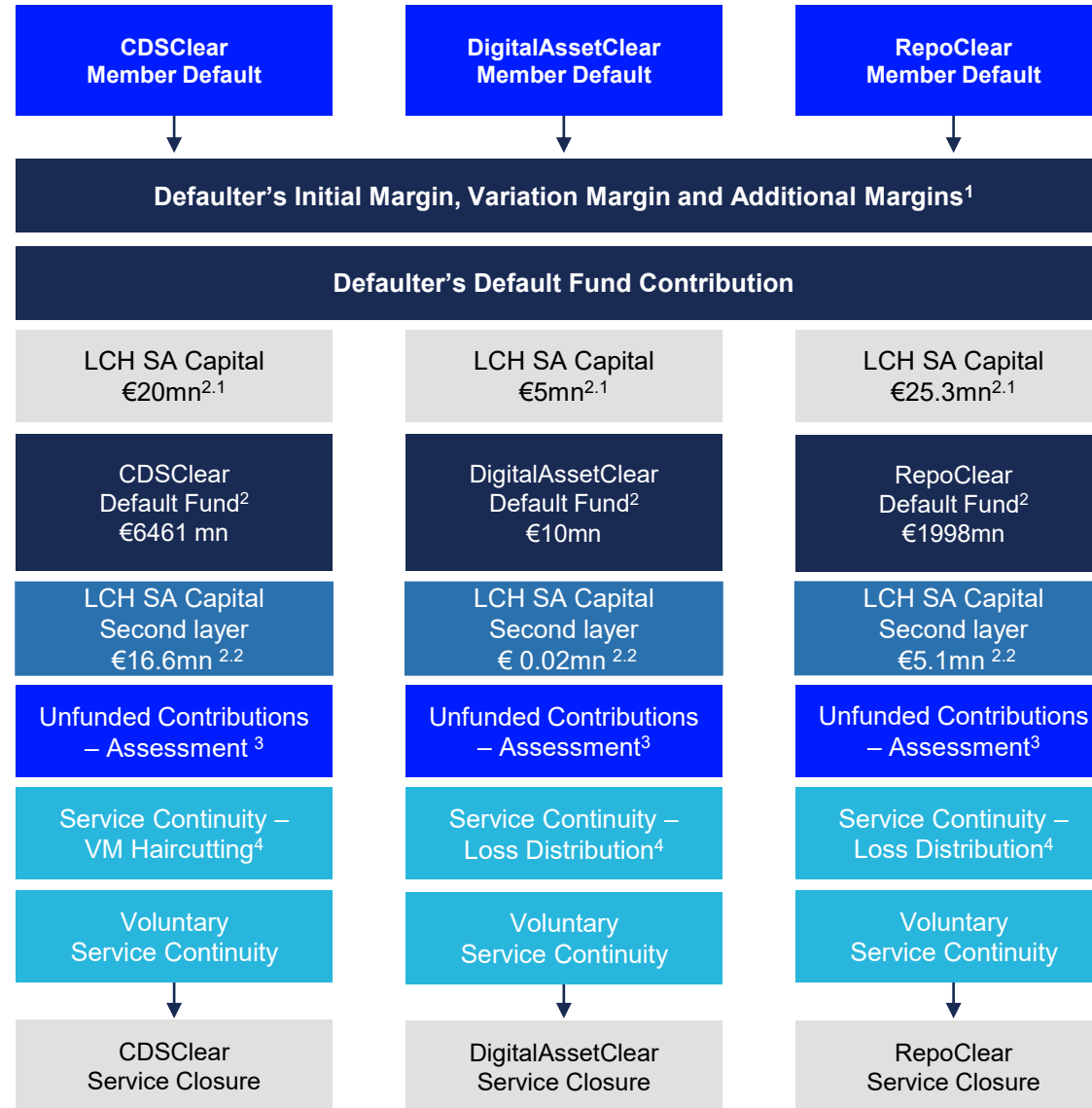


# LCH SA Default Waterfall



1. LCH SA held margin collateral with a market value of €55.1 Bn on the 30<sup>th</sup> of April 2026. (Default Funds not included)

2. The size of each prefunded Default Fund and an indicative allocation of dedicated capital based on the 30<sup>th</sup> of April 2026 position resizing.

1. First layer of skin in the game (a temporary breach of the Article 45 (3) RTS 153/2013 has been logged, CDSClear rulebook states a fixed 20m€ SITG, allocation is not performed in proportion to the size of each default fund with an adjustment being introduced, action to change to a 20m€ SITG floor is ongoing. DigitalAssetClear rulebook states a 5m€ SITG floor).

3. Assessments are callable up to the value of each member's Default Fund contribution at the time of the default.
