Project Poet Circular

We refer to the circular (the “**Circular**”) proposed to be sent by London Stock Exchange Group plc (“**LSEG**”) to its shareholders on or around the date hereof:

- (i) containing, among other things, details of the proposed sale by LSEG’s wholly owned subsidiary, London Stock Exchange Group Holdings (Italy) Limited, of the entire share capital of London Stock Exchange Group Holdings Italia S.p.A. to Euronext N.V. for €4.325 billion payable in cash, which constitutes a Related Party Transaction for LSEG under the Listing Rules of the FCA (the “**Transaction**”); and
