

**Turquoise Global Holdings Europe B.V. Liquidity Provision Scheme on the Turquoise Lit™ Order Book (the “Scheme”)**

**Proprietary Trading Firms Declaration**

‘**Proprietary Trading Firms**’ are Turquoise Trading Members whose trading flow is solely generated from the firm’s own capital with no related client order including the hedging of client CFD and other derivative positions.

This declaration should be signed, scanned and provided by email to [sales@tradeturquoise.com](mailto:sales@tradeturquoise.com) by 16:00 Amsterdam time on the last business day of the month in order to qualify for the Scheme in the calendar month immediately following.

Where a Proprietary Trading Firm is no longer to be included in the Scheme, the Proprietary Trading Firm must inform Turquoise by email to [sales@tradeturquoise.com](mailto:sales@tradeturquoise.com) by 16:00 Amsterdam time on the last business day of the calendar month prior to the calendar month that the Proprietary Trading Firm should no longer be included in the Scheme.

We hereby declare, for the purposes of qualifying for the Scheme, that the Firm is a Proprietary Trading Firm.

We acknowledge that Turquoise reserves the right to carry out verification of the Firm’s activity in relation to this declaration to confirm our qualification for the Scheme, including visits to the Firm’s offices and/or premises for this purpose on 5 business days’ notice. We shall also allow Turquoise and its agents and employees to have access to, and to inspect our accounts, records and other documents and permit Turquoise to take copies for this purpose.

We agree that if Turquoise concludes in its sole discretion, either through a verification visit or otherwise, that the Firm should not have qualified for the Scheme, Turquoise reserves the right to withdraw the benefit and to add to the Firm’s future monthly invoice such amount as reflects the fees which would have been payable by the Firm had the reduced monthly subscription fee not been applied, together with interest at the rate of 3% over the HSBC Bank plc base lending rate calculated on a daily basis, such interest to be compounded at the end of each calendar month, commencing on the due date and continuing until fully paid.

Turquoise reserves the right to amend or withdraw the Scheme at its sole discretion.

This declaration shall be governed by Netherlands law.
