# **Turquoise Hard Brexit Contingency Planning Update**

The purpose of this notice is to update customers on Turquoise's Hard Brexit contingency plans.

As an update to the Market Notice published on 30 July 2019, Turquoise plans to now make only European Economic Area (EEA) securities available on Turquoise Global Holdings Europe B.V. ("TGHE" or "Turquoise Europe"), whilst UK, Swiss<sup>1</sup>, US and EEA securities will be made available on Turquoise Global Holdings Limited ("TGHL" or "Turquoise UK").

Both markets will operate independent Turquoise Lit™, Turquoise Plato Lit Auctions™ and Turquoise Plato™ Order Books (including Turquoise Plato Block Discovery™ and dark-lit sweep).

Turquoise would also like to remind customers that it intends not to invoke its Brexit contingency plans unless there is a 'Hard Brexit', i.e. if the UK was to leave the EU without a transition agreement and/or without relevant equivalence decisions in place to allow cross-border services between the EU and UK to continue.

Turquoise will confirm its plans in advance of any launch of Turquoise Europe should there be a change to the potential Hard Brexit date.
